



CHILD SAFEGUARDING STATEMENT

LSP information

Meath Local Sports Partnership (Meath LSP) develops, supports and provides opportunities for children to participate in sport and physical activity programmes and events in Meath. Meath LSP's office is based in the Townhall, Navan, Co. Meath and has thirteen staff.

Meath LSP believes that the best interests of children attending our activities are of paramount importance. We believe that all children attending our activities have the right to be protected, treated with respect, listened to and to have their views taken into consideration in decisions affecting them.

Principles to safeguard children from harm

Meath LSP is committed to safeguarding children, and by working under the guidance of our Safeguarding Policies, our staff, service providers and partners, working with children, throughout the organisation, seek to create a safe environment for children to participate in sport and physical activity. The following set of principles should be adhered to:

- Importance of childhood - The importance of childhood should be understood and valued by everyone involved in sport.
- Needs of the child - All children's sport experiences should be guided by what is best for children. This means that adults should have a basic understanding of the emotional, physical and personal needs of young people.
- Integrity in relationships - Adults interacting with children in sport are in a position of trust and influence. They should always ensure that children are treated with integrity and respect, and that the self-esteem of young people is enhanced.
- Fair Play - All children's sport should be conducted in an atmosphere of fair play. The principles of fair play should always be emphasised, and organisers should give clear guidelines regarding acceptable standards of behaviour.
- Quality atmosphere & ethos - Children's sport should be conducted in a safe, positive and encouraging atmosphere.
- Competition - Competition is an essential element of sport and should be encouraged in an age-appropriate manner. A child centred ethos will help to ensure that competition and specialisation are kept in their appropriate place.
- Equality - All children should be valued and treated in an equitable and fair manner regardless of ability, age, gender, religion, social and ethnic background or political persuasion.

Risk Assessment

The Meath LSP written Risk Assessment document indicates the areas of potential risk of harm, the likelihood of the risk occurring, and gives the required policy, guidance or process documents required to alleviate these risks. Below is a summary of our risk assessment which indicated areas of potential harm and policy/procedures in place to mitigate these risks.

The Risk Assessment was undertaken on **13th March 2026**. This risk assessment will be reviewed on or before the *30th January 2028* or immediately following changes in legislation or direction by statutory bodies.

Procedures

Our Child Safeguarding Statement has been developed in line with requirements under the Children First Act 2015, (the Children First: National Guidance, and Tusla's Child Safeguarding: A Guide for Policy, Procedure and Practice). In addition to our Risk Assessment document described above, there are further procedures that support our intention to safeguard children while they are availing of our activities.

Meath LSP has the following procedures in place as part of our Safeguarding Policies:

- Procedures for the management of allegations of abuse or misconduct by staff or Sports Leaders against a child availing of our activities.
- Procedures for the safe recruitment of staff and Sports Leaders to work with children in our activities.
- Procedures for access to child safeguarding training and information, including the identification of the occurrence of harm.
- Procedure for reporting of child protection or welfare concerns to Statutory Authorities.
- Procedure for maintaining a list of the persons (if any) in the relevant service who are mandated persons.
